Taunton Central and Tone Vale

Overview

The Taunton Central and Tone Vale Primary Care Network area is in the centre of the county. The main settlement is the county town of Taunton, which has grown significantly in recent years. This area combines two PCN areas into one for the purpose of this analysis – because both areas are principally served by Taunton town centre, meaning that they are best considered as a single functional region.

Health need is taken from the Taunton Central and Tone Vale PCN area is taken from the health needs profiles for these areas (March 2022) at:




Figure 1: Taunton Central and Tone Vale PCNs Pharmacies (40 and 100 hr), dispensing doctors, GPs, housing sites

The scale of development is higher than most other parts of the county, especially around Taunton town itself. and close to existing services, which should be expected to provide for the increased demand. Bishop's Lydeard is also expected to see high

proportionate growth, but does have an existing pharmacy which can eb expected to cater for the increase. The expected level of housebuilding from 2022 to 2025 in the Taunton Central and Tone Vale PCN areas is 1700. The Health and Wellbeing Board expects that if this is exceeded by no more than 50% (850 more additional dwellings) in the period then there will not be a resultant gap in provision. This will be monitored by the Strategic Information Providers group of local authority planners. The Board considers it very unlikely that these levels will be achieved. If these thresholds are breached, then the Health and Wellbeing Board will consider whether a new statement of need is required; however, unless a large majority of such unexpected development takes place on sites distant from existing pharmacies (and we note that such large sites are not part of current plans) then we would expect that such growth would be served by existing contractors.

Pharmacies and Items per head

Taunton Central and Tone Vale (Somerset)

There are currently 16 pharmacies in Taunton Central and Tone Vale as of May 2022. Of these, twelve pharmacies are owned by national pharmacy chains:

- 6 by Boots Pharmacy
- 2 by Bestway pharmacy
- 1 by Lloyd's Pharmacy
- 1 by Morrison's Pharmacy
- 1 by Superdrug Pharmacy
- 1 by Asda Pharmacy

There are 4 other pharmacies in Taunton Central and Tone Vale not part of national pharmacy chains. There are no 100-hour pharmacy in Taunton Central and Tone Vale as of May 2022 and sixteen 40-hour pharmacies.

All pharmacies are Community Pharmacist Consultant Service (CPCS) accredited providing a total of 1,131 CPCS consultations in the first 9 months of 2021/22. In addition, all pharmacies have access to Electronic Prescription Service (EPS).

There are no distance-selling pharmacies and no pharmacies with local pharmaceutical services contracts as of May 2022. There are no dispensing appliance contractors in Taunton Central and Tone Vale.

Since the last PNA was published no pharmacies have closed and no new pharmacies have opened in Taunton Central and Tone Vale. Over the last three years provision in Taunton Central and Tone Vale has been as follows:


The number of items dispensed has decreased overall by 3.7% between 2018/19 and 2020/21.

The number of items dispensed per head in 2020/21 was below the South West and England averages. The number of pharmacies per 100,000 population is lower than the 2020/21 South West and England averages.

7.3.2 Access to the essential services (core plus supplementary opening hours)

- 4 pharmacies are open 7 days a week
- 11 pharmacies are open on Monday to Saturday only
- 1 pharmacies are open on Monday to Friday only
- No pharmacies open before 8am between Monday to Friday
- 3 pharmacies are open until after 6.30pm only on Mondays to Fridays.

7.3.3 Access to Medicines Use Review (MUR)

Based on data for the first 9 months of the 2021/22 financial year, a total of 0 MURs were carried out in Taunton Central and Tone Vale as the service has been decommissioned. This is compared to 2020/21 where 1,596 reviews were performed, 2018/19 where 5,595 reviews were performed.

7.3.4 Access to New Medicines Service (NMS)

All pharmacies in Taunton Central and Tone Vale had NMS accreditation as of May 2021/22. Over the first 9-month period of 2021/22, there were 1,822 NMSs undertaken. This is compared to the whole of 2020/21 where a total of 1,298 NMSs were undertaken.

7.3.5 Access to the 'on demand availability of specialist medicines' enhanced service

As of May 2022, one pharmacy in Taunton Central and Tone Vale provides the specialist medicines enhanced service (Asda Pharmacy, Creechberrow Road, Taunton).

7.3.6 Access to dispensing of appliances

No data provided on pharmacy appliance dispensing.

8.2.1 Influenza vaccination advanced service

15 pharmacies in Taunton Central and Tone Vale delivered the influenza vaccination advanced service as of May 2022. A total of 7,030 vaccinations were given according to the NHSBSAs Advanced Flu Vaccination Service report dataset during the 2021/22 flu season in Taunton Central and Tone Vale locality pharmacies matched with the Somerset STP influenza report pharmacies.

8.2.2 Stoma appliance customisation advanced service

No pharmacies in Taunton Central and Tone Vale provide the Stoma customisation advanced service as of May 2022. There was no activity for this service between 2018/19 and 2021/22

8.2.3 Appliance use review (AUR) advanced service

No pharmacies in Taunton Central and Tone Vale provide this service as of May 2022. There was no AUR advanced service activity between 2018/19 and 2021/22.

There is an acute hospital in Taunton (Musgrove Park) with its own dispensary. There is also a community hospital at Dene Barton, also Taunton.

Necessary services: gaps in provision

Necessary services: gaps in provision

The health needs of Taunton Central and Tone Vale vary little from the county average and do not suggest pharmaceutical needs fundamentally different for the area. The maps of travel times (see main report) suggest that there is adequate access for the large majority of the population, which is concentrated in Taunton itself.

Opening hours for pharmacies cover weekdays, Saturdays and Sundays in accordance with the criteria set out in the main document. However, we note that these hours – which would be expected for the largest settlement and county town – are dependent on supplementary, rather than core, hours, and so more vulnerable to change.

Such arrangements did not constitute a gap in provision for the approximately equivalent area in the 2018 PNA. Although there has been considerable growth since 2018 it has not been at a level or location that has created a gap in provision.

It should be noted that a gap was identified for Monkton Heathfield (east of Taunton) outside the PNA process in 2017. Permission has been granted to John Ware to fill that gap, although the pharmacy has not yet opened.

On the basis of the information we have, we therefore conclude that there is no current gap in the provision of necessary services in the Taunton Central and Tone Vale PCN areas, assuming that the pharmacy in Monkton Heathfield opens as intended.

The level of housebuilding expected in the next three years is higher than the average for the county as a whole. The majority of new housing is on the outskirts of Taunton, close to the existing extensive provision, which can be expected to cater for the growth. An additional 1700 dwellings are expected over the PNA period; unless that number is exceeded by more than 850 we would not seek to review the

evidence for pharmaceutical need.

On the basis of the information we have, we conclude that if the expected level of development in Taunton Central and Tone Vale takes place then there will be no gap in provision of necessary services.

Improvements or better access: gaps in provision

We note that all advanced services, apart from Appliance Use Reviews and Stoma Customization, are provided from pharmacies in the locality. We note that both are available in Taunton Central and Tone Vale from Distance Appliance Contractors,

On the basis of the information we have, we do not assess there to be a current gap in other relevant services in Taunton Central and Tone Vale.

The growth in population will not create demand for any entirely new service.

On the basis of the information we have, we do not assess there to be a future gap in other relevant services in Taunton Central and Tone Vale.
